Region 4 (AL, FL, GA, KY, MS, NC, SC, TN)

DR-4709-FL:

• The State of Florida and FEMA are operating a new Disaster Recovery Center (DRC) in Broward County. Location: Sadkin Community Center, 1176 NW 42nd Way, Lauderhill, FL 33313. This is in addition to the center currently operating at: Hortt Park, 1700 SW 14TH Court, Fort Lauderdale, FL 33312. Hours for both centers are Monday through Saturday, 9 a.m. to 8 p.m. Closed Sundays.

DR-4712-TN:

- FEMA announced that federal disaster assistance has been made available to the state of Tennessee to supplement recovery efforts in the areas affected by severe storms, straight-line winds and a tornado from March 1-3, 2023.
- Public Assistance federal funding is available to the state, eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities in Benton, Bledsoe, Campbell, Carroll, Cheatham, Clay, Crockett, Davidson, Decatur, Dickson, Fentress, Gibson, Giles, Grundy, Hamilton, Hardin, Haywood, Henderson, Henry, Hickman, Houston, Humphreys, Jackson, Lake, Lauderdale, Lawrence, Lewis, Macon, Madison, Marion, Meigs, Monroe, Montgomery, Moore, Obion, Perry, Pickett, Polk, Rhea, Robertson, Stewart, Sumner, Tipton, Wayne and White counties.

DR-4697-MS:

• Supporting the development of, and providing technical assistance to, long-term recovery committees assisting survivors in Monroe, Sharkey, Humphreys, Carroll, and Montgomery Counties.

Region 5 (IL, IN, MN, MN, OH, WI)

DR-4704-IN:

- VALs coordinated with Sullivan County disaster case manager, Community Services Section (CSS), and state counterpart to inquire about a possible late application for Disaster Unemployment Assistance (DUA) for a survivor who had significant barriers to applying to DUA during the 30-day application period. May 23rd CSS sent inquiry to US Department of Labor and Indiana Department of Workforce Development, who responded with encouragement for the applicant to submit a late application with explanation of the circumstances.
- VALs attended the Lion's Club meeting in Sullivan County to provide an overview of available FEMA assistance.
- VALs provided Johnson County and Sullivan County disaster case management information to DRC, CARS, and HelpLine for referrals and coordinated with Recovery Analytics Division (RAD) staff to refresh a report of registration IDs with a release of information (ROI) attached to their case. VALs use this FIDA to review completed ROIs and make referrals to disaster case managers as authorized.
- Sullivan County disaster case management has requested technical assistance on FEMA's rental assistance program and re-certification. VALs are coordinating with IA Liaison to provide program guidance.
- VAGS provided an overview of IA to new External Affairs (EA) staff and VALs provided technical assistance to Johnson County disaster case management lead regarding privacy and information sharing with FEMA, including via written consent of the applicant or a data sharing agreement and collaborated with DRC Coordination to integrate disaster case managers into the Sullivan County DRC. Sullivan County disaster case managers are expected to work from the DRC beginning Tuesday, May 30th.
- May 25th VALs participated in the state-led Housing Task Force meeting; received a request from Sullivan County long term recovery group (LTRG) for aggregate registration data; and attended the Sullivan County LTRG meeting.

DR-4611-LA:

- VALs have assisted applicants receive \$3,037,731.26 in additional IHP funding through case review and appeals
- VALs have received 2,649 (+12) referrals; 2,521 (+6) of those cases are closed and 128 (+6) are open
- VALs have received 3,563 (+57) Duplication of Benefits requests from disaster case management agencies and have completed 3,544 (+72) to date.
- Voluntary agencies report 975 (+1) Homes have been repaired/rebuilt and 326 (-1) homes are pending home repairs/rebuilding.

DR-4706-OK:

- VALs partnered with Catholic Charities of the Archdiocese of Oklahoma City (CCAOKC) providing Casework Training
- VALs are participating Casework Working Group made up of State, LASO, CCAOKC, CCEOK and St. Vincent De Paul
- VALs are conducting VAL Referral Training for DR-4706 IA Branch
- VALs are conducting preliminary discussions with the State regarding LTRG formation for this DR
- VALs are working with IHP and DIA to address escalated unmet needs/AFN cases

DR-4657-OK:

- As of 5/24/2023, 867 applications have been approved for disaster assistance through FEMA's Individual Assistance Programs for more than \$5.2 million in Adair, Cherokee, Muskogee, Okmulgee, Pottawatomie, Seminole, and Tulsa Counties.
- Region 6 VAL continues to provide virtual support to Catholic Charities of Oklahoma City, Catholic Charities of Eastern Oklahoma, and Green Country Behavioral Health Services Disaster Case Managers with case reviews to help prevent duplication of efforts.
- As of 4/27/2023, the Seminole and Pottawatomie County Long-Term Recovery has funded more than \$12,854 in unmet needs funding for building materials, personal property, labor, etc.

Region 6 (AR, NM, LA, OK)

DR-4698-AR:

- As of 5/23/2023, there are 58 households in Cross County who are eligible for Direct Housing Program.
- All DRCs in Pulaski and Cross Counties will be closed in observance of Memorial Day on Monday, 5/29/2023. All DRCs will resume normal hours of operations on Tuesday, 5/30/2023.
- VALs have received 17 referrals; 11 referred to non-profits for help with immediate and unmet needs; 6 still open.
- As of 5/24/2023, there is a population of 338 survivors residing in non-congregate shelters, per American Red Cross.
- As of 5/24/2023, 3,396 applicants have been approved for disaster assistance through FEMA's Individual Assistance Program for more than \$7.7 million in Cross, Lonoke, and Pulaski Counties.
- FEMA Hazard Mitigation Outreach Specialists will be available at two different local hardware stores this week to answer questions about rebuilding from previous disasters and protecting homes from future disaster related damage.

- The VALs are coordinating with AR Division of Emergency Management (ADEM) and AR VOAD on coordinating informational sessions in Cross and Pulaski Counties for local, state, and national partners who have resources for money, manpower, and/or materials. Dates for these sessions are TBD and will provide overviews on the sequence of delivery, LTRG/Unmet Needs Committee development, and FEMA Individual Assistance Programs.

DR-4652-NM:

- Under the Hermit's Peak/Calf Canyon Claims Office, partial payments allow claimants to receive compensation quickly for losses that can be documented with simple or straightforward documentation. The first step in the claims process is to submit a Notice of Loss which can be found online or at one of the Claims Offices in Las Vegas, Mora, and Santa Fe.

 - Las Vegas Claims Office (Temporary Location) | 366 Luna Drive, Las Vegas, NM 87701

- VALs have received 175 referrals with 145 cases being referred to non-profits for help with unmet needs and 30 cases pending.
- The Mora San Miguel Hermit's Peak/Calf Canyon (MSM HPCC) LTRG Unmet Needs Committee has approved 31 unmet needs cases for \$125,121.77 in funding, to date.

Region 9 (CA, NV, HI, AZ, Guam, Northern Mariana Islands, American Samoa)

DR-4713-SOBOBA BAND OF LUISEÑO INDIANS:

• Federal disaster assistance has been made available to the Soboba Band of Luiseño Indians to supplement tribal recovery efforts in the areas affected by the severe winter storm and flooding Feb. 23-26, 2023. Public Assistance federal funding is available to tribal governments on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by the severe winter storm and flooding on tribal lands. Federal funding is also available on a cost-sharing basis for hazard mitigation measures.

FEMA-4683-DR-CA:

- FEMA VALs deployed to the Coastal, Inland, and Southern CalOES regions and are coordinating with state VALs to provide coverage for all IA designated counties. FEMA VALs continue to identify local needs and recruiting resources to support.
- FEMA VALs host daily synchronization calls with State VALs.
- Supporting LTRG discussion, formation, and engagement in Monterey, Merced, Santa Barbara, and Ventura
- Regular participation in Merced County Long Term Recovery Group (MCLTRG) and formation. MCLTRG next meeting is May 26.
- Coordinating with Ventura County VOAD. VOAD deliberating if LTRG is needed or VOAD committee is adequate.
- Monterey LTRG in process of scheduling initial meeting; date TBD
- Invited to attend Santa Barbara VOAD meeting June 8

FEMA-4699-DR-CA

- VALs host daily synchronization calls with State VALs.
- FEMA VAL coordinating with State VAL to identify unmet needs in Tulare and Kern Counties.
- FEMA VAL engaged in Tulare County Long Term Recovery Group (LTRG).
- Onboarding new Local Hire for San Bernadino VAL assignment.
- Supporting survivors in Tuolumne and Mariposa Counties with application process inquiries. Supporting data collection on damaged private roads.



Partners in Action: California

SLOAN.



In early March 2023, flooding from the Sierra Nevada washed away the only entrance into the Tule River Indian Reservation. This left the residents blocked off from food, water and electricity for about a week. Flood waters cut off domestic water, sewer lines, telephone poles and bridges across the reservation. The tribe is working hard to rebuild, but it is going to take a lot of time and resources.

Sloan is providing restrooms, while the Tule River Yokuts rebuild their community. The restrooms are fully sponsored and provided by Sloan to support communities throughout the United States. They were designed to assist first responders, volunteers, and disaster survivors alike. FEMA Provides Assistance and Flexibilities in Support of the End of the COVID-19 Incident

FEMA published the <u>COVID-19 Pandemic: Public Assistance Disposition Requirements for Equipment and Supplies Frequently Asked Questions (Version 2)</u> document, which provides updated guidance on what to do with remaining equipment and supplies when a project is complete. FEMA has obligated over \$62 billion in Public Assistance funding to support the unprecedented response to the COVID-19 incident, which ended May 11, 2023. As the incident closes, states, tribal nations, territories, localities, and private nonprofits may have excess supplies and equipment no longer essential or usable. To help address the surplus, FEMA is providing the following assistance and flexibilities:

- Funding disposal of eligible FEMA-funded equipment and supplies, including necessary transportation.
- Accepting \$0 fair market value for expired equipment and supplies.
- Accepting remaining fair market value for un-expired equipment and supplies based on current market conditions.
- Funding disposition of eligible equipment and supplies that FEMA provided as Direct Federal Assistance.
- Funding warehousing costs during the disposition period (until Aug. 9, 2023).
- Extending time needed for demobilization, disposition, and disposal beyond the original deadline of Aug. 9, 2023.



New Fire Information and Analytics Platform Launched

The <u>U.S. Fire Administration (USFA)</u> announces the launch of the modernization effort to develop a new, interoperable fire information and analytics platform, known as the National Emergency Response Information System (NERIS), for the American fire and emergency services. This effort is being carried out as a partnership between USFA and the <u>US Department of Homeland Security's Science and Technology Directorate (S&T)</u>. The goal of NERIS is to empower the local fire and emergency service community by equipping them with near real-time information and analytic tools that support data informed decision making for enhanced preparedness and response to incidents involving all-hazards.

The platform will integrate data from multiple federal data sets, computer-aided dispatch (CAD) and other authoritative live data sources — to inform community risks including vulnerable populations, the Wildland Urban Interface (WUI), drought areas and flood plains. Further, it will support rapid data capture from hostile event response, including response to structure fires, emergency medical incidents and hazardous materials events.

This project is made possible through a research & development contract awarded through S&T's Long-Range Broad Agency Announcement program awarded to The Fire Safety Research Institute (FSRI). FSRI is a part of UL Research Institutes, the nonprofit safety science organization within the UL enterprise. In collaboration with USFA, DHS S&T and the American fire service, FSRI will develop and provide the new NERIS platform for use by fire and emergency service departments nationwide.

The new NERIS platform will replace the legacy data system (known as the National Fire Incident Reporting System — NFIRS) with a secure, cloud-hosted platform that will fulfill the USFA's National Fire Data Center's (NFDC) obligation under the Federal Fire Prevention and Control Act of 1974 (PL 93-498) — to mitigate the fire problem, reduce loss of life and property and educate the public on fire prevention and protection, as well as effects of all-hazards. Once NERIS is developed and operational, USFA will work to migrate fire and emergency service departments onto the new platform. The legacy NFIRS will remain operational throughout the transition process so all fire and emergency services departments should continue to use the current NFIRS data system and maintain status quo until migrated to the new platform. 
News You Can *Share*: Prepare with Pedro - Wildfires
